CONDITIONS OF ENTRY

1. The Committee reserves the right to refuse entries due to programme restrictions. Payment does not guarantee acceptance.
2. The event will be conducted under FEI/EFA rules. Australian Helmet Standards will apply.
3. All riders and owners must be financial members of the EFA.
4. All horses must hold current registration and grading cards. Points will be checked with the EFA before acceptance of entries for Class 4.
5. **Entries to classes will be limited to 35 horses due to daylight limitations. Enter early!**
6. The Organising Committee reserves the right to alter or amend any of the conditions, regulations or any aspect of the event they see fit. The Organising Committee reserves the right to swab horses at random.
7. A rider is an "Amateur" if they are 21 years and over and have never competed in a World Cup.
8. A rider is a "Junior" until the end of the calendar year in which he/she reaches the age of 18 years. (EFA Addendum to FEI Rules of Jumping Aug. 2001)
9. A rider is a "Young Rider" from the year of their 16th birthday to the year of their 21st birthday. (EFA Addendum to FEI Rules of Jumping Aug. 2001)
10. To be eligible to compete, competitors must complete the Indemnity forms and return them with their entries.
11. Only horses competing in the current competition may use the practice area. Only 6 horses will be allowed in the practice area at any one time.
12. Horses entering Class 4 must be C or D Grade as at 1st January, 2009.
13. Entries for the Grand Prix must qualify from Class 5 'The Welcome Stakes' – max. 20 horses. Horses who do not qualify from Class 5 may nominate for Class 8 'Mini Prix'. Final nominations must be made within one hour of the conclusion of Class 5 on Saturday.
14. Dogs are to be restrained at all times.

Horse Sports are a Dangerous Activity

In consideration for being permitted to participate in any way in horse sport activities and in particular this event, I, the undersigned, understand, acknowledge and accept that:

Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is a significant risk that serious INJURY or DEATH may result from horse sport activities and in particular this event.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of The Equestrian Federation of Australia and/or the event organiser (hereafter referred to as the "Releasees") or others and I voluntarily PARTICIPATE at my OWN RISK and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during this event.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the CANCELLATION of my participation in the event and my immediate removal from my horse NO MATTER where that may occur. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the Releasees against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all times whilst participating in the sport where this is required under the relevant EFA and FEI rules and regulations and agree that I am solely responsible for ensuring that whilst participating I wear a suitable helmet at all times where required under the relevant EFA and FEI rules and regulations and take sole responsibility for my actions.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless and agree not to sue The Equestrian Federation of Australia and/or the event organiser, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, state bodies, affiliated clubs and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise.

Effect of this Document: I have had sufficient opportunity to read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without inducement of any kind.
